

## PERMISSION TO DEPOSIT AGREEMENT

This Agreement is made between the \_\_\_\_\_  
(hereinafter, "DEPOSITOR" and the Digital Library of Information Science and  
Technology (hereinafter, "DLIST ").

DEPOSITOR and DLIST agree as follows:

1. That DEPOSITOR, the undersigned below or its authorized agent, holds the copyright and/or the right and ability to grant permission for the use as described in this Agreement of certain Works described below in paragraph 2, WORKS.

2. WORKS - The subject of this Agreement is the following:

Works that are freely and openly accessible on the organization's website,

3. DEPOSITOR acknowledges that she/he/it understands the following:

A. DLIST serves as the cross-institutional discipline repository for Library and Information Science and Technology .

B. DLIST is part of a global network of research information. As a result of this participation, and the grant of permission to harvest and deposit the WORKS that the content of the DLIST Repository is accessible through the Open Archives Initiative (OAI) Protocol for Metadata Harvesting. The material will be also be available electronically to members of DLIST for scholarly purposes and not for commercial gain.

C. The material is being deposited for open access use and DLIST acquires by this document the non-exclusive permission from the DEPOSITOR to allow DLIST to manually or automatically harvest WORKS, deposit them into the repository, and make the materials available to researchers and practioners in LIS, IT, and other qualified participants throughout the world via the internet .

D. DEPOSITOR is not transferring any copyright interests in the works to DLIST except the right to utilize the works as described in this Agreement. All copyright rights and interests reside with the author or copyright holder. DLIST is not responsible for any copyright interests or issues and is only the repository for WORK S described above in paragraph 2.

E. DEPOSITOR by signing this Agreement certifies that she/he/it has the authority to deposit the works and agrees to hold DLIST harmless from any liability for depositing the WORKS without authority. DEPOSITOR is responsible for clearing any rights prior to submitting materials to DLIST or granting permission to DLIST to harvest and/or deposit the WORKS into the repository.

F. The DEPOSITOR is not being compensated for his/her/its work by DLIST and DLIST is not using the WORKS for Commercial purposes nor charging any fees for access to the WORKS, except as disclosed in the terms of this Agreement.

**I have read, understand, and agree to the above terms of the Permission and Deposit Agreement. I grant DLIST limited permission, as defined in this Agreement, to the WORKS. I understand that I retain all copyright interests in the WORKS except as may be delineated in the Agreement.**
